Any shareholder may participate in this meeting either in a personal capacity, by appointing a proxy, or by means of a postal vote, in accordance with the conditions laid down in Articles L. 225-106 and L. 225-107 of the French Commercial Code.

The right to participate in this meeting is evidenced by the registration in the share account in the name of the shareholder or the intermediary registered on his or her behalf either in the registered share accounts held by the issuer or in the bearer share accounts held by an authorised intermediary in accordance with Articles L. 211-3 and L. 211-4 of the French Monetary and Financial Code (Code Monétaire et Financier).

The registration of the shares in the bearer share accounts kept by the authorised intermediary must be ascertained by a certificate of share ownership issued by the latter on the second business day prior to the meeting by midnight, Paris time.

All shareholders may obtain the documents provided for in Articles R. 225-81 and R. 225-83 of the French Commercial Code, allowing them to give their proxy or vote by post and to vote in an informed manner and on the resolutions that will be presented for their approval, by registered letter with acknowledgement of receipt addressed to CREDIT MUTUEL ASSET MANAGEMENT, Service Juridique, 4, rue Gaillon, 75002 Paris, France.

Proxy or postal voting forms must be received by CREDIT MUTUEL ASSET MANAGEMENT no later than three days before the meeting is due to be held.
